Based on a report Tr.V.Sankaralingam, Advocate addressed Secretary, Public Works Department, Secretariat, Chennai, which was forwarded along with a forwarding letter dated 28.08.2014 by the Principal Secretary to Government, PWD, Chennai Detailed Enquiry vide DE.96/2014/PWD/TK was conducted into the allegations against the marginally noted accused 1. Tr.Su.Gangaatharan, formerly A.E.E., PWD/WRO, Lower Tamirabarani Basin Sub-Division, Srivaikuntam, 2. Tr.V.M.Vinoth Kumar, AE, PWD/WRO, Thamirabarani Basin Division

and 3. Tr.A.Kartheesan, Contractor (Private Individual) that A1 misappropriated a sum of Rs.10,65,000/-, by framing false records as if works were executed at Kanam Surplus Course, Authoor Supply Channel, Puraiyoor Channel, Kanam Feeding Channel, Nallur Supply Channel, Ellappanayakkan Supply Channel and Sethukkuvaithan Channel during the period from 30.01.2012 to 30.03.2012, and indulged in illegal sale of sand from Srivaikuntam Dam area, by issuing bogus permits, printed and signed by him under the pretext of sending the sand for PWD works, and supplied water to Industries, intended for agriculture purpose, and obtained several lakhs of rupees and a Bolero Jeep TN 69 AE 6446 as bribe from benefited owners of industries, and the detailed enquiry revealed the following facts:

The accused Tr.Su.Gangaatharan (A1) who is presently working as Executive Engineer, Korampallam Aru Basin Division, Thoothukudi, had previously worked as Assistant Executive Engineer, Lower Tamirabarani Basin Sub-Division, Srivaikuntam from 23.09.2010 to 22.11.2012 and the accused Tr.V.M.Vinoth Kumar (A2), Assistant Engineer, Thambrabarani Basin Division who is presently working at Maruthur Melakkal Section, Srivaikuntam, had been previously in-charge of South Main Channel Section from August 2006 to December 2012. Both are Public Servants within the ambit and purview of section 2(c) of the Prevention of Corruption Act, 1988, and Tr.A.Kartheesan (A3) who is a registered contractor in PWD, is a private individual.

It is revealed that according to the entries made in Cash Register of Lower Thamirabarani Basin Sub-Division, Srivaikuntam and M.Book Nos.8777, 8791, 8907, 8919, 8917, 8922, 8923, 8756, 8918, 8914, 8905, 8908, 8920, 8921, 8910, 8916, 8904, 8880, 8877, 8881, 8786, 8787, 8793, 8754, 8751, 8731, 8733 and 8753, a total amount of Rs.13,79,024/- had been paid by hand receipts for the works purporting to have been executed under the name "Rehabilitation of South Main Channel and its System tanks in Srivaikuntam Anicut of Thoothukudi District".

It is revealed that the details of works purporting to have been executed and the value of works purporting to have been executed were recorded as to names of channels, works allegedly executed with LS, amounts for the work by A2 and total amount of Rs.13,21,895/- was paid to the contractor A3, and a total amount of Rs.57,129/-, paid in the name of 82 individual workers by way of splitting up the works in such a way that the value of each work is well within the payment powers of A1 & A2 (i.e.,) Rs.500/- for A2, and above Rs.500/- but below Rs.1000/- for A1. Hand Receipts for the value upto Rs.500/- were passed by A2, and those for the value of above Rs.500/- and upto Rs.1000/- were passed by A1.

It is revealed that the works for a total value of Rs.13,79,024/- is alleged to have been executed without any tender, estimate and sanction, and without following the Tamil Nadu Public Works Department Code and the Tamil Nadu Financial Code by A1 & A2 for their own benefits and caused expenditure of Government funds to a sum of Rs.13,79,074/-.

It is revealed that during the period between December 2011 and March 2012, A1 to A3 entered into criminal conspiracy, and in pursuance of the same, A1 and A2 framed incorrect records, committed the offences of criminal misappropriation, criminal breach of trust, cheating, and forgery, and by their criminal misconduct, abused their positions as public servants and committed misappropriation and loss to the Government. It is further revealed that A2 by way of recording false measurements and passing hand receipts for the value upto Rs.500/- for payment, A2 by way of passing hand receipts for the value of above Rs.500/- and upto Rs.1000/- for payment and A1 paid a total amount of Rs.13,21,895/- to A3 by 9 cheques and obtained pecuniary advantage, and A2 by way of paying an amount of Rs.57,120/- to 82 labourers, when actually works were not at all executed, and thereby obtained pecuniary advantage for the aforesaid contractor in respect of the work of "strengthening the eroded low level portion by doing earth work using hard soil" in (1) Ellappanaicken Surplus Course LS 0 M to LS 14000 M, (2) Kadamba Surplus Course LS 5000 M to LS 9800, (3) Kanam Surplus Channel LS 0 M to LS 6800 M, (4) Authoor Supply Channel LS 0 M to LS 12800 M, (5) Poraiyoor Channel LS 0 M to LS 6425 M, (6) Kanam Feeder Channel LS 1800 M to LS 5365 M, (7) Nallur Supply Channel LS 0 M to LS 2100 M, (8) Ellappanaickan Supply Channel LS 0 M to LS 1695 M, and (9) Sethukkuvaithan Channel LS 0 M to LS 4800 M, and A2 obtained pecuniary advantage in respect of the work of Kadamba Surplus Course LS 9800 M to LS 13950.

The act of the A1 to A3 reveals a suspicion of commission of cognizable offences U/s. 120-B, 167, 409, 465, 467, 468, 471 and 477A IPC and Sec.13 (1) (c) and 13(1)(d) r/w 13(2) of the Prevention of Corruption Act, 1988 r/w 109 IPC by the accused.

Therefore, I am a registering a case in Thoothukudi Vigilance and Anti-Corruption Crime No. 3/2018 u/s. 120-B, 167, 409, 465, 467, 468, 471 and 477A IPC and Sec.13 (1) (c) and 13(1)(d) r/w 13(2) of the Prevention of Corruption Act, 1988 r/w 109 IPC on 01.10.2018 at 14.00 hrs against the above said accused for a thorough investigation of the matter.

The original FIR is submitted to the Hon'ble Chief Judicial Magistrate cum Special Judge, Thoothukudi and as per instructions, I am sending a copy of FIR to
