The fact of the case as follows.

Based on a credible information collected by an officer of the Vigilance and Anti-Corruption Department through source that the A1 and A2 colluded with others have prepared false documents and misappropriated government funds in implementing the sanctioned works in Nagakudaiyan Panchayat, during 2012-13 by creating false documents as if works were done without doing the work and caused

loss to the Government and hence a Detailed Enquiry was conducted and the Enquiry revealed the following facts.

A1.Tr.N.Vijayakumar, worked as the Block Development Officer (formerly) Vedaranyam Panchayat Union Office, Vedaranyam Taluk, (Now) Block Development Officer/ Manager, District Rural Development, District Collectorate, Nagapattinam District at the relevant period of occurrence.

- A2. Tr.P.Sukumar was Panchayat Union Overseer, on deputation at Panchayat Union Office, Vedaranyam Taluk, Nagapattinam District at the relevant period of occurrence and now Union Overseer, Block Development Officer, Keelaiyur, Nagapattinam District.
- A3. Tmt.T.Pushpavalli, W/o.Thangarasu was Panchayat President, Nagakudaiyan Panchayat, Vedaranyam Union, Nagapattinam District at the relevant period of occurrence and at present Private Individual.
- A4. Tr.K.Chelladurai was Panchayat Vice-President, Nagakudaiyan Village Panchayat, Vedaranyam union, Nagapattinam District at the relevant period of occurrence and at present Private Individual.
- A5. Tr.V.Thangarasu, Husband of A-3, Nagakudaiyan was a Private Individual. A1 to A4 are public servants within the meaning of Section 2(c) of the Prevention of Corruption Act, 1988 and A5 is Private Individual.

It is revealed that A1, A3 to A5 conspired with A2, without constructing rain water savings system in the ponds at 1) Perappankulam 2) Sammankulam and in 3) Puthiyakulam in Nagakudaiyan Village Panchayat in Vedaranyam taluk. Fabricated false documents as if rain water savings system were constructed in the above three ponds during the period 2012-2013 and by using the forged documents as genuine, falsified the accounts as if a sum of Rs.22,500/-was spent from Nagakudaiyan village panchayat fund and claimed the said sum of Rs.22,500/- Having dominion and control over the funds of

the said panchayat, issued cheques in the name of three fictitious persons and by forging the signatures of their names on the reverse side of the cheques withdrew the amount through A5 and committed criminal breach of trust to the tune of Rs.22,500/-.

It is revealed that in pursuance of their criminal conspiracy A3 & A4 passed resolutions in the Nagakudaiyan Village Panchayat on 09.03.2013 to lay red gravel road from Jeevanagar Uthirapathi house to Vairavanpettai link road in Nagakudaiyan village fund and fabricated false documents as if red gravel road was laid from Jeevanagar Uthirapathy house to Vairavanpettai during the year 2013 and claimed a sum of Rs.94,345/- and A4 prepared false voucher on the direction of A3 and A2, issued completion certificate and the cheque was prepared by A4, signed by A3 and A4 and issued on 09.04.2013 by dishonestly concealing the fact that the red gravel road was not formed, in the name of A.Kandasamy, a fictitious person, which was received by A5, who forged the signature of Kandasamy and withdrew the cheque amount of Rs.94,345/- on 09.04.2013 from the Canara Bank at Kuravapulam.

It is further revealed that in pursuance of the said criminal conspiracy A3 to A5 conspired with A2 prepared by boosting M-book measurement, Estimate, Final contract certificate by forging the signature of AE Tr.Mohanasundram during the year 2014 and as per the super check report, they showered red soil for a value of Rs.35,875/- and red gravel worth of Rs.64,124/- but without showering the red gravel misappropriated the said sum of Rs.64,124/-.

The above information collected during Enquiry, discloses suspicion of commission of cognizable offences u/s 120(B), 167,409,468,420, 471, 477(A) IPC and Section 13(2) r/w 13(1)(c) of the

Prevention of Corruption Act, 1988 against A1 to A4 and u/s 120-B, 167 r/w 109, 468 r/w 109,471 r/w 109,471 r/w 109,420,477-A r/w 109,409 r/w 109 of IPC and 13(2) r/w 13(1) (c) of Prevention of Corruption Act, 1988 r/w 109 of IPC against A5.

Hence, I am registering a case in Vigilance and Anti-Corruption, Nagapattinam Cr.No.5/2018, U/s. 120(B), 409,167,468,420,471,477(A) IPC and Section 13(2) r/w 13(1)(c) of the Prevention of Corruption Act,1988 and U/s. 120-B, 167 r/w 109,468 r/w 109,471 r/w 109, 420, 477-A r/w 109, 409 r/w 109 of IPC and 13(2) r/w 13(1)(c) of Prevention of Corruption Act 1988 r/w 109 of IPC against A1 to A5 on 02.08.2018 at 13.00 hrs.
