## ATTACHMENT TO COLUMN No.12 OF FIRST INFORMATION REPORT IN VIGILANCE AND ANTI-CORRUPTION, SALEM DETACHMENT CRIME No.06/AC/2018.

Tr.L.Rajaraman A-1 was working as Inspector of Labour, Salem from 4.7.2008 to 20.10.2010 and was holding additional charge of Labour Officer (SSS), Salem and not allowed to retire on 31.08.2015.

Tr.T.Kumaresan A-2 was working as Superintendent in the O/o the Deputy Commissioner of Labour Salem since 1996 and from 1.11.2008 to 30.04.2010 he was working as Superintendent in the O/o the Labour Officer Salem (SSS) and retired on 30.04.2010.

Tr.N.Gopal A-3 was working as Assistant in the O/o the Labour Officer (SSS) Salem from 10.11.2008 to 13.9.2010 and now serving as Stamping Inspector-1<sup>st</sup> Circle, Salem.

The accused A-1 to A-3 are public servants as defined u/s 2 (c) of the Prevention of Corruption Act, 1988.

A Detailed Enquiry was ordered by the Director of Vigilance and Anti-Corruption, Chennai, in memo No. DE.59/2015/LB/SL Dt.19.05.2015 against Tr.V.Rajaraman, Labour Officer, Salem, formerly Inspector of Labour I/c Labour Officer (SSS) Salem with the concurrence of the Vigilance Commissioner as conveyed in letter No. 1473/VC.1/2015-1 dated 5.5.2015 and after completion of Detailed Enquiry (DE.59/2015/LAB/SL), the Director of Vigilance and Anti Corruption, Chennai instructed to register a Regular Case in his letter No. DE.59/2015/LAB/SL dated 27.11.2017 and accordingly FIR is registered.

The Govt. of Tamil Nadu, with intent to regulate the employment and working conditions and to provide Social Security to the un-organized workers enacted "Tamil Nadu Manual Workers (Regulation of Employment and Conditions of Work) Act, 1982. Under this Act, Govt. of Tamil Nadu, in G.O. (Ms) No.198 Labour and Employment Department, dated 04.10.1994, formulated the Tamil Nadu Manual Workers (construction workers) Welfare Scheme, 1994. Subsequently, the Govt. of Tamil Nadu, in their G.O Ms. No.35, Labour and Employment Department, dated 17.3.1999, formed the Tamil Nadu Manual Workers Social Security and Welfare Board.

The Govt. of Tamil Nadu, on 01.11.2008, set up an office of the Labour Officer (SSS) in each District to look after registration of members in the Welfare Boards of Un-organized workers and construction workers, to renew their registration periodically and to sanction and disburse financial assistance to the eligible members. In each office of the District Labour Officer (SSS) 17 Welfare Boards were set up and are functioning for the welfare of different kinds of unorganized manual workers including construction workers.

Various financial assistances are provided by the Govt. to the eligible registered manual workers of Tamil Nadu construction workers Welfare Board and other 16 Tamil Nadu Un-organized workers Welfare Boards, including financial assistance of Rs.15,000/- for natural death (to the legal heirs) and Rs.2,000/- for cremation expenses.

For getting registration in the "Tamil Nadu Manual Workers & construction workers Welfare Board" as a member, an unorganized manual or construction worker has to apply to the District Labour Officer (Social Security Scheme) in the prescribed format along with (1) Age certificate, (2) VAO certificate to the effect that the applicant is residing in the given address and engaging in the particular unorganized manual or construction work, (3) educational qualification certificate (4) an attested copy of the family card or voter's identity card. The application should be certified by either the office bearers of the trade union he belongs or, if he is not enrolled his name in any of the trade unions, by the jurisdictional Assistant Inspector of Labour in the specific column of the application to the effect that he is engaging in the particular category of unorganized manual work or construction work and then the filled application shall be submitted with the photo affixed and along with all the aforesaid certificates to the O/o the District Labour Officer (SSS).

The application so received in the O/o the District Labour Officer (SSS) will be scrutinized and if the applicant is found to be eligible his / her name is registered in the concerned welfare board as a member and after assigning registration number an identification card will be issued to that applicant containing the details of his / her name, age, registration number with date, parent or spouse's name, the item of work engaged by the applicant, temporary and permanent addresses, marital status, name of the nominee and the membership number of the trade union if he is a member in any

trade union etc. The applicant should renew his / her registration once in two years. The applicant will be eligible to get the aforesaid financial assistances only if his registration is kept alive. If the age of applicant exceeds 60 years he will become ineligible to get any assistance.

To get financial assistance of Rs.15,000/- for natural death of any registered member and Rs.2,000/- for cremation expenses, the nominee of the deceased has to submit an application in the prescribed format to the Labour Officer The original Identity Card of the deceased member, a copy of the (SSS) concerned. death certificate and an attested copy of the family Ration Card of the nominee shall be enclosed along with the application. On receipt of application at the office of the Labour Officer (SSS), the Labour Officer (SSS) will forward the same to the jurisdictional Assistant Labour Inspector for field verification to confirm the genuineness of the details furnished in the application and the documents enclosed. The Assistant Labour Inspector will visit the spot and conduct field inspection and he will furnish his inspection report in the prescribed format to the Labour Officer (SSS). Based on the inspection report furnished by the concerned Assistant Inspector of Labour, the District Labour Officer (SSS) will sanction Rs.17,000/- (Rs.15,000/- for natural death + Rs.2,000/- for cremation expenses) to the nominee of the deceased. The amount so sanctioned by the District Labour Officer (SSS) will be sent to the nominee applicant by way of cheque through registered post. Prior to the Year 2010, the applications seeking financial assistance for natural death of registered members were not sent to the jurisdictional Assistant Inspector of Labour for field verification. These applications were scrutinized and verified by the staff and the Labour Officer (SSS) concerned. In this regard clear instructions were issued by the Government vide G.O. (Ms) No.123 Labour and Employment (I.1) Department Dated 24.10.2008. Similarly prior to the year 2010, the cheques were given to the applicants in person, under acknowledgement. of Rs.15,000/- is being sanctioned for the natural death in case of death after 16.9.2005 and if the death occurred prior to 16.9.2005, the amount sanctioned was Rs.10,000/-.

If any discrepancy or defects / ineligibility is noticed during the scrutiny of applications along with the enclosed documents A-2 and A-3 have to bring it to the notice of A-1 who will reject the applications with reasons.

Tr.V.Rajaraman A-1 while he was holding additional charge of the office of the Labour Officer (SSS) Salem, he has recorded as if financial assistance to a sum of Rs.17,000/- (Rs.15,000 + Rs.2,000) each was sanctioned and paid to the beneficiaries for natural death and for cremation expenses to large number of legal heirs of the deceased members and out of it, the following 16 beneficiary's applications were taken up at random during detailed enquiry and the financial assistance sanctioned towards natural death and for cremation expenses were misappropriated by A-1 colluded with A-2 and A-3.

In respect of Tmt.Ponnammal, W/o Kuppan (SI. NO.9) and Tmt.Athayee, W/o Sengodan (SI. No.16), the accused officers had sanctioned financial assistances for their natural death and cremation charges and shown as the amounts were disbursed to their nominees even though Tmt.Ponnammal and Tmt.Athayee are still alive. The applications, death certificates, identification card, stamp receipts for disbursement of amounts, photos and details enclosed in the identity cards and the finger impressions affixed in the identification cards are false and fabricated and the amount of Rs.17,000/- for each claim was misappropriated by A-1 to A-3 during their working period.

In respect of Tr.S.Sugavanam, S/o Subramaniya Iyer (SI. No.10), his brother Tr.S.Sellappan has given application to the accused officers, claiming financial assistance for the death of his brother Tr.S.Sugavanam and the claim amount of Rs.2,000/- was sanctioned by the Deputy Commissioner of Labour, Salem and Rs.10,000/- was sanctioned and cheque No. 058114 for Rs.10,000/- was shown as disbursed to the applicant Tr.Sellappan on 02.07.2009. But the above said amount of Rs.2,000/- and the cheque for Rs.10,000/- was not received by the said Tr.Sellappan and the stamp receipt was fabricated and the amount of Rs.12,000/- was misappropriated.

In respect of claims in Sl. No.1) Tr.Muthusamy, 2) Tmt.K.Sellammal, 3) Tr.A.Jayaraman, 4) Tr.M.Raja, 6) Tr.S.Gandhi, 11) Tr.M.Jayaraman, 14) Tr.Srinivasan



and 15) Tr.Annamalai, none of the applicants submitted any applications claiming any financial assistance as mentioned in the applications. Except the deceased Tr.Gandhi in SI. No.6 the other deceased in SI. Nos. 1, 2, 3, 4, 11, 14 and 15 are not members in the Tamil Nadu unorganized manual workers welfare board and they are not eligible for the claim. In item No.2 the name of the deceased as mentioned in the application viz., Tmt. Sellammal the applicant and her son Tr. Raja are fictitious. There was actually no such persons ever lived in the given addresses. In SI. No.6 in the identity card of the deceased Tr.Gandhi the photograph of some other person other than the deceased was affixed. In the stamp receipt also instead of affixing the photograph of the applicant Tmt.Saroja, some other's photo was affixed. Though the deceased Tr.Gandhi was a member in the Tamil Nadu unorganized manual workers welfare board no application for financial assistance was claimed by the alleged applicant Tmt. Saroja, his wife since, the original membership identity card of the deceased was lost. Tr. Jayaraman was working in the Tamil Nadu state Transport Corporation as Driver and died while on service and he is not eligible to claim financial assistance under this scheme. The applications were bogusly prepared by the accused, forging the signatures of the applicants and enclosing false documents such as death certificates, member identity cards and stamp receipts etc., as if the applicants claimed financial assistance. Accused 1 to 3 in collusion with each other arranged for sanction of the claim amounts with all forged documents using them as genuine and misappropriated the entire amount Rs.17,000/- (Rs.15,000/- for natural death + Rs.2,000/- for cremation expenses) each in all the 8 instances for their illegal gain during their working period.

In respect to the claims for financial assistance under this scheme in the following 5 instances in Sl. Nos. 5) Tmt.Saroja, 7) Tmt.Ayyammal, 8) Tmt.Jothy, 12) Tr.Rajamani and 13) Tr.K.Periasamy, the alleged applicants have not submitted any applications for claiming financial assistance and the signatures found in the applications and stamp receipts are forged. The photographs of the actual applicants were not affixed and the photographs of bogus persons were affixed. The financial assistance of amounts were sanctioned in all these 5 claims at the rate of Rs.17,000/-(Rs.15,000/- for natural death + Rs.2,000/- for cremation expenses) each, and the same was misappropriated by the accused 1 to 3 during their working period.

Making use of the genuine registration number of Tmt.R.Mangaladevi, the accused 1 to 3 managed to get the death certificate, photo of deceased Jothi, created false documents, claim application, Identity card etc., as if her sister's daughter Tmt.Selvamary presented application for claim and sanctioned the amount. Accused 1 to 3 utilized the registration numbers of Tr.M.Saminathan, Tmt.Subbulakhsmi and Tmt.Maheswari to claim amounts in the name of the above 3 persons viz., Tmt.Ponnammal, Tr.Raja and Tr.Muthusamy who were not at all registered their names as members in the Tamil Nadu Unorganized Members Welfare Board. The accused created all false documents and got the claim amounts through the Head Post Office, Salem, by opening SB Accounts in fictitious names.

Thus, A-1 to A-3 in connivance with each other created false documents, forged the signatures in the name of applicants, fabricated the photographs of the applicants and making use of the above false documents as genuine, sanctioned financial assistance in the name of 16 applicants and misappropriated Govt. funds to the tune of Rs.2,67,000/-.

The above said information discloses the commission of cognizable offences punishable u/s 120-B, 409, 467, 468, 471 and 477A IPC and u/s 13(2) r/w 13(1) (c) & (d) of the Prevention of Corruption Act, 1988 r/w 109 IPC.

Hence, I am registering a case in Salem V&AC Cr.No.6/AC/2018, u/s. 120-B, 409, 467, 468, 471 and 477A IPC and u/s 13(2) r/w 13(1) (c) & (d) of the Prevention of Corruption Act, 1988 r/w 109 IPC.

Original FIR is submitted to the Hon'ble Special Judge, Special Court for Trail of cases under Prevention of Corruption Act, Salem and a copy of FIR is submitted to the Director, Vigilance and Anti-Corruption, Chennai.
