<u>Submitted</u>, based upon information a preliminary enquiry was conducted pertaining to Block Development Office, Vellore, on the alleged purchase of 146 LED Street Lights during the period between 2015 and 2016 and it is found that the bills and payments were made under union general fund, Vellore Union, without actually purchasing the 146 LED Street Lights. The enquiry discloses the following information.

1) Tr. C.Ravi, was formerly Block Development Officer, Vellore Block, Vellore, and then Superintendent/BDO, O/o. the Assistant Director (Audit), Thirupathur, Vellore District and attained the age of superannuation, but not allowed to retire; 2) Tr. L.S.Mohan, was formerly Deputy Block Development Officer, Vellore Block, Vellore, now Dy. Block Development Officer (Admin), Alangayam Block, Vellore District, and 3) Tmt.Rajitha Anandaraj, was Union Chairman, Vellore Union, Vellore, at the relevant period of occurrence but her tenure came to an end now and A-1 to A-3 are public servants as per section 2 (c) of P.C. Act-1988, during the relevant period of occurrence. 4) Tr. Anandaraj being the husband of A-3 Tmt.Ranjitha Anandaraj and 5) The trader M/s. Popular Pipe Centre, No.41/2, Arcot Road, Opposite to Daily Thanthi Office, Vellore are private individuals.

It is the duty of the A-1 Tr. C.Ravi, formerly Block Development Officer (B.P), Vellore Union, to look into utilization of the union general fund as stipulated in G.O.(Ms). No.229 Dt:15.10.1996 of Rural Development Department, Chennai and to take efforts to execute the Welfare Schemes being implemented under Union General Fund. A-1 Tr. C.Ravi, formerly BDO (BP), Vellore Union, is assisted by A-2 Tr. L.S.Mohan, formerly Deputy Block Development Officer (Admin), Vellore Union. During the period between 2015 and 2016 at Union Office, Vellore and at other places in Vellore, A-1 Tr. C.Ravi, A-2 Tr. L.S.Mohan, A-3 Tmt. Ranjitha Anandraj, A-4 Tr. Anandaraj and the trader A-5 Popular Pipe Centre, entered into a criminal conspiracy to commit and abet each other in the commission of the following offences and in pursuance of such conspiracy committed the following acts, to wit;

In pursuance of such conspiracy A-3 Tmt. Ranjitha Anandaraj and her husband Tr. Anandaraj obtained blank letter heads from 5 village panchayat presidents namely Kizhmonavoor, Anpoondi, Melmonavoor, Boodhur and Karugambattur villages and filled the letter heads as if the presidents of the said villages requested for LED street lights.

During the course of same transaction, A-1 to A-3 in connivance with A-4 Tmt.Ranjitha Anandaraj, Ex-Union Chairman, Vellore Union and by abusing their official position, passed a fake resolution without conducting meeting in the Union and in sequence to it obtained 3 quotations from various traders. Based on the said resolution, A-1 Tr. C.Ravi was given work order to A-5 M/s. Popular Pipe Centre, Vellore for the alleged supply of 146 LED street lights to 5 village panchayats, to the sum of Rs.10,00,000/- and A-2 Tr.L.S.Mohan prepared the work order and cheques with his counter signature and made false entries in the Union General Fund cash book and cheques and issued the same to A-5 M/s. Popular Pipe Centre, Vellore. The A-5 M/s. Popular Pipe Centre, Vellore. The A-5 M/s. Popular Pipe Centre, Vellore to A-5 M/s. Popular Pipe Centre, Vellore. The A-5 M/s. Popular Pipe Centre, Vellore actually without supplying the 146 LED street lights, accepted the two SBI cheques Dt:19.02.2016 to the tune of Rs.9,53,900/-.

During the course of the same transaction, A-1 to A-5, by abusing their official position misappropriated the union general fund to the tune of Rs.9,53,900/-, as if it is used for the purchase of 146 LED Street Lights, but in reality without purchasing the LED

street lights and shared the misappropriated amount, among themselves, by framing incorrect documents, creating false document and used the same as genuine one.

The aforesaid information reveals of commission of cognizable offences of conspiracy, framing incorrect documents by public servants, falsification of accounts, forgery, using forged documents as genuine, cheating, criminal breach of trust and criminal misconduct committable by public servant.

Hence, I register an FIR against A-1 to A-3 u/s. 120 B, 167, 468, 471, 477-A, 420 409 of IPC and 13 (2) r/w. 13 (1) (c) and 13 (1) (d) of Prevention of Corruption Act-1988 and against A-4 and A-5 u/s.120 B, 167, r/w. 109, 468 r/w.109, 471, r/w.109, 477-A r/w.109, 420, 409 r/w. 109 of IPC and 13 (2) r/w. 13(1) (c) and 13 (1) (d) of Prevention of Corruption Act-1988 r/w.109 IPC.

On the outcome of the Preliminary enquiry and on the orders of the DVAC/CNI in PE.131/2018/RDP/VL, Dt:12.07.2018 today on 16.07.2018 @ 1500 hrs a case in Vigilance and Anti-Corruption, Vellore Detachment Cr. No. 06/2018 u/s. 120 B, 167, 468, 471, 477-A, 420, 409, 109 IPC and 13 (2) r/w. 13 (1) (c) and 13 (1) (d) of Prevention of Corruption Act-1988 was registered against the accused. The original FIR is submitted to the Hon'ble Chief Judicial Magistrate cum Special Judge, Vellore and other copies to the officers concerned.
