Submitted:- I, E.Mcclarine Eskhol, Deputy Superintendent of Police, Vigilance and Anti-Corruption, Tirunelveli Detachment received the information pertaining to this registration of FIR today on 25.02.2021 at 11.00 hrs as per the instruction in Memorandum No.42531/19/LB/TI dated.02.02.2021 of the Directorate of Vigilance and Anti-Corruption, Chennai-16 and accordingly I registered a case in Tirunelveli Vigilance and Anti-Corruption Cr.No.05/2021 u/s 13(2) r/w 13(1) (e) of Prevention of Corruption Act, 1988. The Accused Tr.Muthudurai is working as A.1 Section clerk at Palayamkottai Ward office of the Tirunelveli City Municipal Corporation, Palayamkottai. He is a public servant within the definition of section 2(c) of the Prevention of Corruption Act, 1988. Tmt.Ambika is the wife of the Accused. She is a home maker. On the basis of credible information that the Accused as public

servant between 01.01.2007and 31.12.2015 (herein after mentioned as the check period) by abusing his official position and by adopting corrupt and illegal means had acquired and in possession of pecuniary resources and properties in his name and in the name of his wife, which is disproportionate to their known sources of income during the period from 01.01.2007 to 31.12.2015 and the following information came to light. As on 01.01.2007 the value of assets both movable and immovable stood on the credit of the accused and his family members are Rs.36,090.00. As on 31.12.2015, at the end of the check period, the value of the assets stood on the credit and found in the possession of the above said accused and his family members are calculated as Rs.51,15,627.00. The total income of the accused and his family members from all the known sources of income during the check period is tentatively calculated as Rs.21,13,361.00. The total expenditure of the accused and the family members during the check period is tentatively calculated as Rs.6,49,311.00. From the above said calculation the likely savings of the accused is arrived as Rs.21,13,361.00 - Rs.6,49,311.00 = Rs.14,64,050.00, whereas the accused had accumulated assets for a value of Rs.50,79,637.00/than the likely saving of Rs.14,64,050.00 during the check period between 01.01.2007 and 31.12.2015. There are sufficient grounds and materials to believe that the above mentioned properties both movable and immovable, investments and pecuniary resources found in the name and possession of the Accused his wife, during the check period is far beyond and disproportionate to the known sources of income of the accused during the check period to the extent of Rs.50,79,637.00-Rs.14,64,050.00 = Rs.36,15,487.00. The above information discloses an offence of criminal conduct by public servant along with his wife punishable u/s 13(2) r/w 13(1) (e) of the Prevention of Corruption Act, 1988.

I, am therefore registering a case in Tirunelveli V&AC Crime No.05/2021 u/s 13(2) r/w 13(1) (e) of Prevention of Corruption Act, 1988 on 25.02.2021 at 11.00 hrs against the accused Tr.Muthudurai for the above said offences for the purpose of taking up investigation.

The original FIR is submitted to the Hon'ble Special Judge, Special Court for Trial of cases under PC Act, Tirunelveli and copies to the concerned.
