It is submitted that, an enquiry was conducted against the marginally noted accused Tr.V.Kurinjivendan, Forest Guard, O/o. Forest Ranger, Udumalpet, Tiruppur District now working as Forest Guard in Srivaikundam Range, Thoothukudi Division and his wife Tmt.P.Chitra. The enquiry revealed the following information:

2) The accused Tr.V.Kurinjivendan (A1) was entered into Government service in Forest Department as temporary work as Social Forestry Worker in Udumalpet range on a Consolidate Pay from 03.10.1984 to 06.08.2009. On 07.08.2009, his post was regularized (permanent employee) as Forest Watcher. During the period from 07.08.2009 to 13.04.2010 and 14.04.2010 to

13.06.2011 he worked as Plot watcher in Social Forestry Coimbatore and Social Forestry respectively. During the period from 13.06.2011 to 03.06.2013 and 08.06.2013 to 30.11.2014 he worked as Forest Watcher in Esal Thittu Udumalpet Range and Karudan Kottai, Kangeyam Range respectively. On 01.12.2014 he was promoted as Forest Guard. During the period from 01.12.2014 to 11.06.2016, 15.06.2016 to 01.12.2017 and 02.12.2017 to 11.02.2018 he worked as Forest Guard in Esal Thittu, Udumalpet Range, in special duty and Kuzhipatty, Udumalpet Range respectively. Further, he underwent 6 months training in TNFA, Vaigaidam for the period from 12.02.2018 to 10.08.2018. During the period from 16.08.2018 to 21.09.2018,

he worked as Forest Guard in Dharapuram Sulal thanikkai, Kangeyam Range, Udumalpet. On 22.09.2018 he was transferred to Valparai range. During the period from 17.10.2018 to 31.06.2019, he worked as Forest Guard in Valparai Range. During the period from 01.07.2019 to till date, he is working as Forest Guard in Srivaikundam Range, Thoothukudi Division.




3) After got marriage with AO, his wife Tmt.P.Chitra started the business with two nursery gardens in the name of Karmugil Nursery Gardens during the year 2004 and 2016 respectively. First nursery garden is running in their own land and is located in Karur Main Road Ramamoorthy Nagar, Kalipalayam, Dharapuram and another garden is running in rented land which is located in Coimbatore Main Road, Nanjiampalayam, Dharapuram. Both of the nursery gardens were invested by the AO because there is no reliable source to AO's wife Tmt.P.Chitra to start that business.

4) They have the only Daughter named selvi.K.Dhavamugi now she is studying IIIrd year MBBS in Vinayaka Mission's Kirupananda Variyar Medical College and Hospitals, Salem and staying in the hostel.

5) The enquiry revealed that, during the period between 01.04.2013 to 30.06.2018, A1 Tr.V.Kurinjivendan while working as Forest Guard, O/o. Forest Ranger, Udumalpet, Tiruppur District by adopting corrupt activities, acquired movable and immovable properties in his name and his wife Tmt.P.Chitra which are disproportionate to their known sources of income. During the period between 01.04.2013 and 30.06.2018, A1 Tr.V.Kurinjivendan was a public servant under section 2(c) of the Prevention of Corruption Act 1988 and his wife Tmt. P.Chitra was a private individual.

6) It is gathered that most of the acquisitive activities of the accused Tr.V.Kurinjivendan and his wife Tmt.P.Chitra falls between 01.04.2013 and 30.06.2018 and hence it was chosen as tentative check period and during that

period the accused Tr.V.Kurinjivendan and his wife Tmt.P.Chitra were found in possession of assets as detailed below.



7) The above information discloses commission of cognizable offences of criminal misconduct committed by public servant punishable u/s 13 (2) r/w 13 (1) (e) of the Prevention of Corruption Act, 1988.

8) Hence, A1 Tr.V.Kurinjivendan being a public servant, while working Forest Guard at Udumalpet Range in Tiruppur District from 01.04.2013 to 30.06.2018, committed the offences punishable under section 13(2) r/w 13(1) (e) of the Prevention of Corruption Act, 1988. A2 Tmt.P.Chitra being wife of A1, abetted and persuaded in commission of offence of criminal misconduct.

9) Thus there are prima facie material available for taking investigation against A1 for the commission of offences punishable u/s 13 (2) r/w 13 (1) (e) of the Prevention of Corruption Act, 1988 the commission of offences punishable u/s 109 of IPC r/w 13 (2) r/w 13 (1) (e) of the Prevention of Corruption Act, 1988. Hence, Today 09.07.2021 at 11.00 hrs, I am registering a case in Tiruppur V & AC crime No.05/2021/AC/TPR, u/s 13 (2) r/w 13 (1) (e) of the Prevention of Corruption Act, 1988 against A1 Tr.V.Kurinjivendan and u/s 109 IPC r/w 13 (2) r/w 13 (1) (e) of the Prevention of Corruption Act, 1988 against A2 Tmt. P.Chitra for the aforesaid offences for the purpose to investigation.

10) The original FIR is submitted to the Court of Chief Judicial Magistrate cum Special Judge, Chief Judicial Magistrate Court, Tiruppur and a copy of it is being sent to the Superintendent of Police, Western Range, Vigilance and Anti-Corruption, Chennai for issuing authorization u/s 17 & 18 of the Prevention of Corruption Act, 1988 to take up investigation in this case.
