

ATTACHMENT OF COLUMN NO.12 OF THE FIRST INFORMATION REPORT IN VIGILANCE AND ANTI – CORRUPTION, SALEM DETACHMENT CRIME NO.06/AC/2022

During the collection of sources, the following information was gathered against the officers noted in the column No.7

Accused No.1 Tr.S.Arumuganainar was working as Executive Officer, Kannankuruchi Selection Grade Town Panchayat, Salem District from 23.04.2018 to 31.01.2021 and now he is working as Executive Officer, Veerapandi Town Panchayat, Theni District.

Accused No.2 Tr.N. Gopiraja was working as Junior Assistant, O/o Executive Officer, Kannankuruchi Selection Grade Town Panchayat, Salem District from 22.12.2018 to 13.05.2020 and now he is working as Executive Officer, Vennanthur Town Panchayat, Namakkal District.

Accused No.3 Tr.N.M.Murugan was formerly working as Assistant Director of Town Panchayats Salem Zone, Salem during the relevant period from 29.01.2018 to 15.12.2019 and retired from service on 31.01.2020 on attaining the age of superannuation. The accused A1 to A3 are public servants as defined u/s 2(c) of the Prevention of Corruption Act 1988.

Director of Town Panchayats, Chennai has instructed all Zonal Assistant Director of Town Panchayats and the Executive Officers in the state that Forms and Registers, papers etc., for office use should be purchased only in the Government Printing Press of the respective districts and the stationary items such as white sheets, ordinary sheets and writing items etc., should be purchased only in the concerned District Cooperative whole sale stores by adopting procedures laid down in Transparency in Tenders Act and relevant rules. Accordingly, for the purchase of articles costing above Rs.10,000/- and below Rs.10 Lakhs, limited tender procedure should be followed. Further, there are specific instructions by the Director of Town Panchayats, Chennai in Circular No.1/2008/C2, dated

25.01.2008, that Stationeries should be purchased from Cooperative Printing Press and issued circular to that effect vide his Circular No.1/2008/E2, dated.25.01.2008.

A-1 being the Executive Officer, is authorized to call for quotations for the purchase of stationary items, electrical, water pipe line materials for the execution of maintenance work and also call for tenders for the purchase of equipments, awarding contracts in accordance with tender procedures. Further, he is authorized to sign all the cheques for the payment from Kannankurichi Selection Grade Town Panchayat, Salem District, after getting sanction order from Assistant Director of Town Panchayats, Salem Zone. A-2 being the Junior Assistant, should assist A-1 in preparation intend for the purchase of stores as per requirements, maintaining Stock Register, preparing bills and other connected files regarding the purchase of materials. A-3 being the Assistant Director, Town Panchayats, Salem Zone, Salem should peruse the requests received from the Town Panchayats under his control and after verification for the correctness of requests in all the aspects, should give sanction orders so as to enable the Town Panchayat administration to release funds.

It was gathered that during the year 2018-19 and 2019-20 the accused A1 to A3 noted in the margin, entered into criminal conspiracy with dishonest intention to defraud the funds of the government by making false entries in the records of the Kannankuruchi Town Panchayat as if stationeries were purchased from Thirumullaivoil Stationary, Printing, Book binding, Aluminum and Leather Manufacturing Industrial Cooperative Society Ltd., Chennai, for the usage of Kannankuruchi Town Panchayat without actually purchasing them and in pursuance of the above criminal conspiracy, A2 Tr.N.Gopiraja being Junior Assistant created forged requisition as if the following stationary items were required to Kannankurichi Town Panchayat and submitted the same to A1 Tr.S.Arumuganainar along with note file and subsequently, A1 approved the same in the note file without resolution of the Town Panchayat Council and sent supply

orders to the above said Thirumullaivoil Stationary, Printing, Book binding, Aluminum and Leather Manufacturing Industrial Cooperative Society Ltd., Chennai on various dates and subsequently, A3 Tr.N.M.Murugan, Assistant Director issued fund sanction orders then and there for the release of funds to the tune of Rs.9,49,558/- in the name of the said Society. Thereby, A1 to A3 jointly misappropriated the government funds to a total sum of Rs.9,49,558/- during the relevant period.

It is further gathered that as per the voucher No.479, dated 09.10.2018, a sum of Rs.1,50,987; voucher No. 771 dated 31.01.2019 a sum of Rs.1,81,461/-; voucher No,817 dated 11.02.2019 a sum of Rs.1,87,014/-; voucher No. 838 dated 25.02.2019 a sum of Rs.30,149/-; voucher No. 93 dated 03.05.2019 a sum of Rs.1,73,845/-; voucher No. 389 dated 20.08.2019 a sum of Rs.2,26,102/-(totally a sum of Rs.9,49,558/-) was misappropriated by A1 to A3 with the active connivance of the Proprietor of Thirumullaivoil Stationery Printing, Book Binding, Aluminium and Leather manufacturing Industrial Coop. Society, Chennai and caused wrongful loss to the town Panchayat fund.

It is further gathered that in respect of Bank Payment Voucher BPV No.817, dated.11.02.2019 for Rs.1,87,014/-, A1 Tr.S.Arumuganainar, Executive Officer, A2 Tr.N.Gopiraja, Junior Assistant and A3 Tr.N.M.Murugan, Assistant Director of Town Panchayats colluded with each other, though the A1 has no authority to purchase and supply the stationeries to A3, since the A3 is the authority competent to purchase the stationeries directly from the concerned Government Printing Press, Salem from the fund allotted to his office, A1 and A3 with the active connivance, prepared forged requisition and supply order, made false entries in the stock register maintained at the O/o the A1 and A3, as if the stationary items were purchased from the above said Thirumullaivoil Stationary, Printing, Book binding, Aluminum and Leather Manufacturing Industrial Cooperative Society, Chennai for a sum of Rs.1,87,014/- and supplied the same to the O/o the Assistant Director of Town Panchayats, Salem from the General fund of Kannankurichi Town Panchayat stated **A3** supra. had issued proceedings Na.Ka.No.1990/2018/P, dated.17.12.2018 to A-1 for the settlement invoice amount Rs.1,87,014/. Accordingly, A1 issued A/c payee cheques in the name of the above said society and the entire amount was misappropriated and shared among them.

Therefore, the information discloses primafacie against A 1 to A3 for the commission of offences of Criminal Conspiracy, Criminal Breach of Trust, Cheating, public servants being bribed and Criminal misconduct by dishonest misappropriation, all punishable u/s 120-B, 167, 409, 420, 465, 468, 471 and 474 IPC and u/s 13(2) r/w 13(1)(a) of the Prevention of Corruption Act 1988 as amended in 2018.
