The Accused No.1 Dr.S.Arul Antony was working as Principal Grade-I, Government Arts College, Udhagamandalam from 05.05.2023. The Accused No.2 Dr.R.Ravi was working as Associate Professor, Department of Botany, Government Arts College, Udhagamandalam from 09.07.2009. Hence, Accused No.1 and 2 are Public Servants within the definition of 2(c) of the Prevention of Corruption Act, 1988.

The Accused No.1 Dr.S.Arul Antony entered into Government Service on 26.03.1993 as Lecturer through Teachers Recruitment Board and served as Principal Grade-I in Government Arts College, Udhagamandalam from 05.05.2023 to till the date of his suspension on 26.09.2023.

The Accused No.2 Dr.R.Ravi entered into Government Service on 09.07.2009 as Assistant Professor through Teachers Recruitment Board and was elevated as Associate Professor on 01.08.2021 and served till the date of his suspension on 26.09.2023.

For the Undergraduate and Postgraduate courses, 3792 students are studying in Government Arts College, Udhagamandalam. There are 18 departments for the Undergraduate courses and 15 departments for the Postgraduate courses. For the 1st year, the sanctioned strength allotted by the Affiliated University is 1323 students in the Undergraduate courses. Of the sanctioned seats, 1044 students are studying in various departments and the remaining 279 seats are vacant during the Academic Year 2023-2024.

During the Academic Year 2023-2024, the admission for the Undergraduate courses commenced from 29.05.2023 to 31.08.2023. Further, on the instruction of

the Directorate of Collegiate Education, the admission period was extended from 12.09.2023 to 14.09.2023.

For the admission of students for the first year of Undergraduate courses, an Admission Committee has to be formed. The Admission Committee should consist of a Chairman (Principal) and the committee members, who are three most senior Associate Professors of the College from any department and one most senior Associate Professor from the Scheduled Caste of any department. The Chairman with the consent of the committee members can give admission and also accord the change of branch for the students.

During the Academic Year 2023-2024, the change of branch in degree course for the students was illicitly performed by A1 and A2 without the knowledge of the Admission Committee and contrary to the existing procedures. Moreover, A1 has dishonestly obtained undue advantage from the 1st year students of the Undergraduate courses in Government Arts College, Udhagamandalam through A2 for the change of branch in degree course from one course to another.

During the Academic Year 2023-2024, the number of students who requested to change the branch of degree course are B.A., Tamil - 3, B.A., History (Tamil Medium) - 3, B.A., History (English Medium) - 13, B.A., Economics (Tamil Medium) - 4, B.A., Economics (English Medium) - 19, B.Com 1st shift - 5, B.Com 2nd shift - 5, B.Sc., Mathematics (Tamil Medium) - 1, B.Sc., Mathematics (English Medium) - 2, B.Sc., Physics (Tamil Medium) - 1, B.Sc., Physics (English Medium) - 2, B.Sc., E&C (Tamil Medium) - 2, B.Sc., Botany (English Medium) - 2, B.Sc., Zoology (English Medium) - 1, B.Sc., WildLife Biology - 1.

The Accused No.2 is maintaining a Savings Bank A/c 58750100010613 in Bank of Baroda, Udthagamandalam Branch. During the Academic Year 2023-2024, A2 has collected undue advantage from 1st year students in person and through his G-Pay number 97515 77497, which stands in the name of Ravi Gayathri for the change of branch in degree course and late admission, as per the instruction of Accused No.1.

Thereby, the Accused No.1 & 2 had dishonestly obtained Rs.5,000/- Rs.10,000/- Rs.9,000/- and Rs.9,910/- as undue advantage from B.Sanjay, G.Charumathi, K.Manoj and V.Rebeshkumar for the change of branch from B.Sc., Maths to B.Sc., Computer Science, from B.A., Tamil to B.Sc., Computer Science, from B.Sc., Physics to B.Sc., Computer Science and from B.A., History(TM) to B.Sc., ECS respectively.

Further, the Accused No.1 and 2 had obtained Rs 6,000/- from J.Fousthina, 1st B.Sc., Computer Science as undue advantage for change of branch from B.A., English to B.Sc., Computer Science. She had paid Rs.2,000/- in person to A2 at

Government Arts College and the remaining Rs.3,000/- sent through A2's G-Pay number 97515 77497.

The Accused No.1 and 2 had obtained Rs.5,000/- from S.Vishal, 1st B.A., Tamil as an undue advantage for change of branch from B.A., Economics (Tamil Medium) to B.A., Defense and again change of branch to B.A., Tamil. On 16.08.2023, S.Vishal had transferred Rs.5,000/- from G-Pay number 91592 96392 in the name of his mother Tmt.Sumitha to A2's G-Pay number 97515 77497 as per the instruction of A2.

The following students were admitted in the UG courses in the extension period of time given by the Directorate of Collegiate Education from 12.09.2023 to 14.09.2023.

Thereby, A1 and A2 had obtained Rs.14,500/- and Rs.10,000/- as undue advantage from K.Sachin of 1st B.Sc., Computer Science and K.Sakthivel of 1st B.Sc., Computer Science respectively for late admission in the extension period.

Moreover, A2, Dr.R.Ravi had obtained Rs.3,000/- and Rs.4,000/- on 19.07.2023, Rs.5,000/- on 22.07.2023, Rs.5,000/- on 24.07.2023, Rs.3,000/- and Rs.2,000/- on 25.07.2023, Rs.5,000/- on 14.08.2023, Rs.5,000/- on 16.08.2023, Rs.2,400/- on 18.08.2023, Rs.2,500/- on 21.08.2023, Rs.8,000/- on 05.09.2023, Rs.2,000/- on 12.09.2023, Rs.5,000/- on 21.09.2023 as undue advantage from the

Undergraduate students of 1st year through G-Pay number 97515 77497 in the name of Ravi Gayathri for the change of branch. The above said amounts were credited in A2's SB A/c No.58750100010613 maintained in Bank of Baroda, Udhagamandalam branch.

Therefore, this FIR being registered after obtaining prior permission from the competent authorities u/s 17A(1) of the Prevention of Corruption (Amendment) Act, 2018. I am registering a case in the Nilgiris V&AC Cr. No.1/2024/AC/NI against Accused No.1 Dr.S.Arul Antony, Principal Grade-I, Government Arts College, Udhagamandalam for the commission of the offence u/s 7(a) and (b) of the Prevention of Corruption Act, 1988 as amended by the Prevention of Corruption (Amendment) Act, 2018 and against Accused No.2 Dr.R.Ravi, Associate Professor, Department of Botany, Government Arts College, Udhagamandalam u/s 7(a) and (b) r/w 12 of the Prevention of Corruption Act, 1988 as amended by the Prevention of Corruption (Amendment) Act, 2018 on 26.03.2024 at 15.00 hrs.

The original FIR is submitted to the Hon'ble Court of Chief Judicial Magistrate, Udhagamandalam and a copy of the FIR is sent to the Superintendent of Police, Western Range, Vigilance and Anti Corruption, Chennai .
