AO-1 Tr.R.Muthukumarasamy, Formerly Revenue Inspector, Aminjikarai Taluk Office, Chennai, Now Senior Revenue Inspector (Elections) Thiruvotriyur Taluk, Chennai.

AO-2 Tr.Dinesh, Private Individual. I (J.Christy), Inspector of Police, Special Investigation, Cell, Vigilance and Anti-Corruption, Chennai-16, while was on duty on 24.04.2025 received DVAC Memorandum dated 08.04.2025 instructing to register a case based on the petition submitted by Tr.S.Prakash. Today I am registering this case at 13.00 hrs in V&AC, Hqrs Cr.No.3/2025, u/s 7 (a) & 7 (b) of Prevention of Corruption (Amendment) Act 2018.

As per memorandum in VR.F.No.204/2024(38832)/REV/SIC dated 08.04.2025 it is directed by the DVAC to register a case against Tr.R.Muthukumarasamy, Formerly Revenue Inspector, Aminjikarai Taluk Office, Chennai, now Senior Revenue Inspector of (Elections) Thiruvotriyur Taluk, Chennai.

The accused officer Tr.R.Muthukumarasamy is the Senior Revenue Inspector of (Elections) Thiruvotriyur Taluk, Chennai, formerly he was working as Revenue Inspector, Aminjikarai Taluk Office, Chennai. He is a Public Servant within the purview of section 2(c) of the Prevension of Corruption Act 1988.

Based on the petition of Tr.Prakash, it is ascertained that, AO-1 Tr.R.Muthukumarasamy, Revenue Inspector, Aminjikarai Taluk Office had demanded Rs.2000/- each for Community, Nativity, Income and OBC Certificate from the petitioner Tr.S.Prakash, S/o.M.Shanmugam, who is residing at Villivakkam, Chennai.

The Information collected from the sources revealed that, AO-1 Tr.R.Muthukumarasamy was working as Revenue Inspector at the office of Tahsildar, Aminjikarai Taluk for the past 1 ½ years. He belongs to Group B category of Government servants. His reputation is not good. He is the Public Servant within the ambit and purview of Section 2(C) of the Prevention of Corruption Act. It is ascertained that, the petitioner Tr.S.Prakash studied Electronics Communication in RMK College of Engineering, Kavarapettai, Gummidipoondi Taluk, Thiruvallur District during the year 2016-2020. He is preparing for Union Public Service Commission Exam. Hence to participate in the competitive exams, he had applied for Community and Nativity certificate for himself and Income certificate for his father Tr.M.Shanmugam through online on 09.08.2024 and OBC certificate on 24.08.2024.

On the same day (24.08.2024) Tr.S.Prakash met AO-1 Tr.R.Muthukumarasamy at his office and enquired about his certificate. At that time, AO-1 had demanded Rs.2,000/each for Nativity, Community and Income certificate and Rs.3,500/- for his OBC certificate. Subsequently AO-1 has forcibly demanded Tr.S.Prakash to offer him the bribe amount of Rs.2,800/- and received the said amount on that day itself. After accepting the bribe amount, the Nativity and Community certificate were released on 25.08.2024 and 26.08.2024 respectively. Later, on 28.08.2024 Tr.S.Prakash met the AO-1 and enquired about the remaining two certificates. Consequently he demanded and accepted Rs.1,000/- through the private individual Tr.Dinesh, AO-2 at his office. Further, AO-1 conveyed the petitioner that he would visit his house for field verification at any time.

As said by AO-1 earlier, on 30.08.2024 he contacted from his Mobile No. 9384094051 to Tr.S.Prakash Mobile No.7299213382 and conveyed that he is on the way to his house for field verification. Hence he informed his father Tr.M.Shanmugam about the arrival of AO-1 Tr.R.Muthukumarasamy and recorded the conversation happened between them in his mobile as material evidence. During field verification, AO-1 had forcibly demanded and accepted Rs.5,500/- from the petitioner's father through the private individual Tr.Dinesh AO-2 for recommending and forwarding the same for the approval of the Income and OBC certificate. Thus AO-1 had accepted the total bribe amount of Rs.9,300/- instead of Rs.9,500/- from the petitioner Tr.S.Prakash for recommending and forwarding the above 4 certificates.

Hence Tr.R.Muthukumarasamy, AO-1 committed offence u/s 7 (a) & 7 (b) of Prevention of Corruption (Amendment) Act 2018 by demanding & accepting an undue advantage, for recommending and forwarding the Community, Income, Nativity and OBC certificate. Further the private individual Tr.Dinesh, AO-2 committed offence u/s 12 of

Prevention of Corruption (Amendment) Act 2018 by accepting undue advantage as directed by AO-1.

The act of accused officer, A.O-1 Tr.R.Muthukumarasamy and A.O-2 Tr.Dinesh attracts offences under 7 (a) & 7 (b) of Prevention of Corruption (Amendment) Act 2018 r/w 12 of PC (Amendment) Act 2018.

The Prior permission as per sec 17(A) (1) of the Prevention of Corruption (Amendment) Act 2018 was obtained in the proceedings of the District Collector, Chennai District vide in A4/e-2992755/2025, dated 21.02.2025.

Hence I am registering a case in V&AC, Hqrs Cr.No.3/2025, u/s 7 (a) & 7 (b) of Prevention of Corruption (Amendment) Act 2018 r/w 12 of PC (Amendment) Act 2018 on 24.04.2025 against AO-1 Tr.R.Muthukumarasamy, formerly Revenue Inspector, Aminjikarai Taluk Office, Chennai, now Senior Revenue Inspector of (Elections) Thiruvotriyur Taluk, Chennai and AO-2 Tr.Dinesh, Private Individual.

The FIR is submitted to the Hon'ble Court of the Special Judge, Special Court for PC Act cases, Chennai along with the Complaint of Tr.S.Prakash, Transcend Micro 8GB SD card Black Colour and 63(4) Certificate of BSA with Hash value copy. A copy of FIR is submitted to DVAC, Headquarters.
