As per the order of the Managing Director, Tamil Nadu Women's Development Corporation, Chennai, 3932/P2/2019 dated 8.10.2019 and 4.3.2020, the project funds of Rs. 895 lakhs and 447.50 lakhs have been released for the integrated Villupuram district at the Panchayat level federation for the year 2019-20.

As per the order of the Managing Director, Tamil Nadu Women's Development Corporation, Chennai, 2530/P2/2020 dated 7.08.2020 and 11.1.2021, the project funds of Rs. 447.5 lakhs and 317.00 lakhs have been released for the integrated Villupuram district at the Panchayat level federation for the year 2020-21.

As per the orders of the Managing Director, Tamil Nadu Women Development Corporation, Chennai and as per the procedural order of the District Collector, Villupuram, the funds from the Panchayat Level Federation Fund debited on 14.11.2019, 25.11.2019, 30.4.2020, 6.10.2020, 28.4.2021 and 29.6.2021 should be released to the Community Investment Fund as per the government guidelines.

By violating government procedures when there was no need, In collusion with the accused 2 to 6, Accused 1 directly purchased sewing machines, flour milling machines and Photocopies machines worth Rs. 29,06,358/- from Abi Enterprises and Spectra Auto Machine, Salem, for the Mailam and Kanai Panchayat level associations through the Community Investment Fund which is revealed in Resolution book and

bank account book without the order of Managing Director, Tamil Nadu Women Development Corporation, Chennai and District Collector, Villupuram. Hence AO-1 in collusion with other accused 2 to 6 has misused the Community Investment Fund and made purchases worth Rs.29,06,358 and by compelling block machine managers through his power, to collect cheques from Panchayat level associations, collected the cheques and make payments to Accused 6's company which is registered in the PLF registers in the Panchayat level federations through the Project Director's office. The CIF utility certificate does not mention anything about the purchase of sewing machine, flour milling machine and xerox machine from PLF bank account.

Since there is no need for the machines purchased by the self-help groups and the quality of the machines is poor, many of the machines received by the self-help groups have been returned to the Panchayat level federation. Many of the machines were in disrepair and are not in use.

Some Panchayat level federations have given cheques to Spectra Company in Salem without distributing machines to Self-Help Groups. Due to the purchase of poor quality machines, there is lack of income from them. Hence the monthly repayment amount of Rs.75,71,374/- is pending from 111 panchayats.

Since the price of the machines was quoted at a high level, 139 Panchayats did not come forward to get the machines. They are kept in the VPSC buildings. They have wasted money to the tune of Rs.96,51,230/- on the above unused machines.

Rs.28,89,274/- has been misused from the Community Investment Fund in 41 Panchayats and the corresponding machines have not been received.

Thus Government funds to the tune of Rs. 2,03,71,228/- have been misused in providing Public Investment Fund and Vulnerability Reduction Fund to Self Help Groups in Villupuram district by AO-1 in collusion with A2 to A5 through their official powers in receiving cheques from Panchayat level associations and paying them by cash to A-6's Company. Therefore, there are enough evidences for commission of cognizable offences punishable u/s 120B, 409, 420, 468 IPC and 13(2) r/w 13(1)(C)of Prevention of Corruption Act 1988 against the marginally noted accused.

Hence, this day 22.04.2025 at 16.45 hrs. I am registering a case in V&AC, Viluppuram in Cr.No.05/2025 u/s 120B, 409, 420, 468 IPC and 13(2) r/w 13(1)(C)of Prevention of Corruption Act,1988 against the marginally noted accused.

The original F.I.R. is submitted to the Honourable Court of the Special Judge for Cases under Prevention of Corruption Act, Viluppuram and a copy of it is being sent to the Superintendent of Police, North Range, Vigilance and Anti-Corruption, Chennai.
